(\*) - 1 post earmarked for PWBDs in respective departments.

Persons with Benchmark disabilities (PwBDs) - 4% Horizontal Reservation shall be applicable as per GOI instructions.

Physical requirements for PwBDs- S (Sitting), ST (Standing), BN (Bending), MF (Manipulation by Fingers), W (Walking), SE Seeing), RW (Reading and Writing), H (Hearing), C (Communication). Categories of disabled suitable for job- OA (One arm), OL (One leg).

**Note:** In case of seats reserved under EWS, OBC, SC & ST categories, UR Candidates may appear for the walk-in interview. In case, candidates under any of these categories do not appear or report, UR Candidates will be allowed to appear for the interview.

#### 1. QUALIFICATION:

- A. Post Graduate Degree i.e. MD/MS/DNB/DM/M.Ch or equivalent in the above Departments recognized by Medical Council of India / NMC/ NBE.
- B. For Dentistry only candidates with MDS in conservative & endodontics are eligible to apply.
- C. For Clinical Haematology seats candidates with MD in General Medicine and MD in Paediatrics will also be considered.

#### 2. AGE LIMIT:

The upper age limit for applying these posts is 45 years.

Cut-off date to determine eligibility in terms of age of candidates will be the date of walk-in interview SC/ST/OBC/PWBD candidates who opt to apply for unreserved vacancies will not be eligible for age relaxation otherwise allowed to those belonging to these categories. Further, reserve category candidates (SC/ST/OBC/PWBD) who become eligible by virtue of age relaxation applicable in their will be consider only for reserved seats of the category to which they belong even if they have the merit to be considered otherwise for UR.

Age relaxation is permissible to various applicants is as under: -

- 1. SC/ST- 5 years
- 2. OBC 3 years
- 3. PWBD- 10 years
- 4. Ex Servicemen Candidate- 5 years.

#### 3. APPLICATION FEES & MODE OF PAYMENT:

➤ General/OBC Category : Rs 1500/-➤ SC/ST/EWS Category : Rs 1200/-

Ex-servicemen/Women/PwBD candidate is exempted from any fee.

Application fee is required to be remitted through Demand Draft only. The **Demand Draft should be drawn** in favour of AlIMS, Patna payable at AlIMS, Patna. Any other instrument of payment is not acceptable. The application fee is non-refundable.

- a) For filling up of application on the date of walk-in interview, the candidates have to bring the following documents (original and one set of self-attested copies) which also needs to be produced at the time of walk-in interview:-

- The picture should be in colour, against a light-coloured, preferably white background
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Demand Draft in original (if applicable)  $\triangleright$
- Aadhar Card
- AAAAAAAA Date of Birth/SSC/HSSC pass certificate (mentioning Date of Birth)
- MBBS Degree Certificate
- MD/MS/DNB/DM/M.Ch Degree/Provisional Degree Certificate
- UG & PG NMC/State Registration Certificate
- Category/PwBD Certificate (If seat is claimed in reserved category)
- Experience Certificate, if any
- NOC from present employer (applicable for those working in Govt./Pvt. organization)
- Any other relevant documents (viz. Research Work, Publication etc.)
  - b) The candidates are requested to fill the correct details regarding name/age/gender/caste/address/educational qualification and other relevant fields mentioned in the application form.
  - c) Once form is submitted, there shall be no provision for making changes in the application form.
  - d) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

#### 5. **RESERVATION:**

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 5% for PwBD candidates (on horizontal basis).
- For OBC-NCL Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from date of walk-in interview. Candidate must submit the OBC certificate issued by the competent authority of Govt. of India in Format given by DOPT/ Govt. of India or for the appointment to the Central Government Job.
- For EWS Candidates: Candidate(s) must attach certificate valid for the posts under the Central  $\triangleright$ Government of India which mentions that the Candidates does belong to EWS category. Date of issue of Certificate should not be earlier than 1 year from date of walk-in interview.

- b) All Candidates must provide phone numbers and E-mail for faster communication.
- c) Those who have already completed 03 years of their Senior Residency, are not eligible to apply.
- d) Qualification/Experience will be counted as on date of interview
- e) The final result will be displayed on the website i.e. (www.aiimspatna.edu.in).
- f) Eligibility is subject to verification of the documents on the day of Walk-in Interview.

### 9. METHOD OF RESOLVING TIES:

All Tie cases (more than one candidate having same marks) have been resolved on date of birth. Older candidate (earlier date of birth) is ranked above younger candidate.

#### 10. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

APPLICATION/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/ REJECTED IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- i. Applications being incomplete.
- ii. Any variation in the Signatures.
  - All the SIGNATUREs in FULL (NOT IN SHORT) done on the Application Form and also on other Documents must be the same.
- iii. Non-payment of application fees through Demand Draft, if not otherwise exempted.
- iv. Fee not paid as per instructions.
- v. Under aged/over aged candidates.
- vi. Failure to bring (in original) all relevant Certificates/Documents issued by the competent authority, along with self-attested legible copies in support of the information given in their Application Forms about their Educational Qualifications; Experiences; Percentage of Marks obtained; Proof of Age; Proof of Category [SC/ST/OBC/EWS/PwBD] at the time of Walk-in Interview and/or verification of document.
- vii. Not having the requisite Educational Qualification/Experience/Category Status as on **the date of interview.** Incorrect information or misrepresentation or suppression of material facts.
- x. Any other irregularity.

#### 11. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

- (A) Candidates are warned that they should not furnish any particulars that are false or suppress any material information while filling in the application form. Candidates are also warned that they should in no case attempt to alter or otherwise tamper with any entry in a document or the attested certified copy submitted by them nor should they submit a tampered/fabricated document.
