1. QUALIFICATION (As on 09.07.2025)

- The candidates should have passed MBBS (including completion of Internship) from the MCI/NMC recognized Institute.
- NMC/MCI/State Registration is mandatory to be produced before joining, if selected.

2. AGE LIMIT (As on 09.07.2025)

For eligibility to apply for these posts, upper age limit will be 37 years. Age limit relaxation for SC/ST candidate up to a maximum period of 5 years and for OBC Candidates up to a maximum period of 3 years.

In the case of Orthopedic/ Physical handicapped (OPH) candidates, age limit is relaxable up to maximum period of 05 years for General Category, 08 years for OBC category and 10 years for SC/ST candidates.

4. APPLICATION PROCESS:

Candidates, who are fulfilling the eligibility criteria may fill the application form which will be available at www.aiimspatna.edu.in. After final submission of form, candidates have to take a print of the same, which along with following documents (**original and one set of self-attested copies**) needs to be produced at the time of interview:-

- Date of Birth/SSC/HSSC pass certificate (mentioning Date of Birth)
- MBBS Degree Certificate
- Internship Completion Certificate
- UG/PG NMC/State Registration Certificate
- Category/PwBD Certificate (If seat is claimed in reserved category)
- Experience Certificate, if any
- NOC from present employer (applicable for those working in Govt./Pvt. organization)
- Any other relevant documents (viz. Research Work, Publication etc.)

5. RESERVATION:

- a. The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 4% for PwBD candidates (on horizontal basis).
- b. For OBC-NCL Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application.
- c. For EWS Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does belong to EWS category. Date of issue of Certificate should be from six month from last date of application.
- d. For EWS, OBC-NCL, SC and ST – Certificate should be issued by Tehsildar or above rank authorities prescribed by Govt. of India in format of State/Central Government.

6. PAY SCALE: Rs. 56,100/- as per 7th CPC, Level – 10 of the Matrix + NPA for Medical Graduates only plus usual allowances as admissible.

- Aadhar Card.

i. Photograph (in JPG format):

- Photograph must be a recent of passport size.
- The picture should be in colour, against a light-coloured, preferably white, background.
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Dimensions 200 x 230 pixels (preferred)
- Size of file should be between 80 kb–100 kb
- Ensure that the size of the scanned image is not more than 100 KB.

ii. Signature (in JPG format):

- The applicant has to sign on white paper with Black ink pen.
- Dimensions 140 x 60 pixels (preferred)
- Size of file should be between 50 kb – 80 kb
- Ensure that the size of the scanned image is not more than 80 KB.

- (f) After completing the registration part candidate will receive the user ID and password through E-mail on the registered email address. The same ID and Password shall be displayed on the logged screen. Candidates are requested to note down the User ID and password. Candidates are also advised to take a print of the Registered Application Form for their records and future reference.
- (g) The candidates already registered shall click on existing user link and fill the correct user ID and Password for continuing the form filling process. In case of incorrect User ID/Password click on the 'forgot password' link.
- (h) The candidates are requested to fill the correct details regarding name/age/sex/caste/address/educational qualification and other relevant fields mentioned in the application portal. Candidates are advised to upload the relevant documents/photographs in the desired format only.
- (i) Once the details are correctly filled the candidate may proceed for the fee payment.
- (j) Once a candidate clicks on SUBMIT button, a page containing some important instructions for payment, a Payment Reference Number and a Link to make payment of Application Fee will open. Candidates are advised to take a print of the Registered Application Form for their records and future reference. Thus, the process for Registration of candidates who have to pay Application Fee gets completed. The Registration number along with Date of Birth can also be used for downloading the Admit Card prior to the date of examination which shall also be notified in the designated website i.e. www.aiimspatna.edu.in

(l) Once form is submitted, there shall be no provision for making changes in the application form.

(m) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

9. **SELECTION PROCESS:**

- Written test (MCQ based) will be held for selection to the advertised posts of Junior Residents (Non – Academic).
- Total Number of questions will be 100, carrying one marks each. There will be no negative marking.
- Duration of written (MCQ based) examination will be 01 hours and 30 minutes.
- Qualifying marks for written test will be as under:**
UR: 50 % OBC-NCL/EWS: 45 % SC/ST: 40 %
- Final Selection list will be declared solely based on the marks obtained in written examination.
- While every effort will be made to intimate the candidates regarding Examination schedule at the earliest, the responsibility lies with the candidate to check for the same on the institute website. All Candidates must provide phone numbers and E-mail for faster communication at the time of application.***
- The final result will be displayed on the website i.e. (www.aiimspatna.edu.in).

10. **METHOD OF RESOLVING TIES:**

All Tie cases (more than one candidate having same marks) have been resolved on date of birth. Older candidate (earlier date of birth) is ranked above younger candidate.

11. **TERMS OF RECRUITMENT:**

- Initial appointment of selected Candidates will be for a period of 06 months.
- On receiving application from candidate, the tenure may be extended for another six months base on recommendation received from concerned Head of the department and approval received from Executive Director.
- After initial appointment a maximum of 01 extension of 06 months may be granted based on fulfilment of criteria mentioned in point no. 02.
- Maximum permissible work period (including initial appointment and 01 possible extension thereafter) for the post of Junior Resident (Non-Academic) will be 12 (twelve) months. After completing 12 months, no further extension will be given.

- i. Applications being incomplete.
- ii. Any variation in the Signatures.
All the SIGNATUREs in FULL (NOT IN SHORT) done on the Print out of the Application Form and also on other Documents must be the same.
- iii. Scanned copy of photograph and signature uploaded are not as per specification given and/or blur or distorted or not clear.
- iii. Non-payment of Examination Fees or non-receipt of fee through online mode, if not otherwise exempted.
- iv. Fee not paid as per instructions.
