1. QUALIFICATION (As on 20.02.2026)

- (i) The candidates should have passed MBBS (including completion of Internship) from the MCI/NMC recognized Institute.
- (ii) NMC/MCI/State Registration is mandatory to be produced before joining, if selected.

2. AGE LIMIT (As on 20.02.2026)

For eligibility to apply for these posts, upper age limit will be 37 years. Age limit relaxation for SC/ST candidate up to a maximum period of 5 years and for OBC Candidates up to a maximum period of 3 years.

In the case of Orthopedic/ Physical handicapped (OPH) candidates, age limit is relaxable up to maximum period of 05 years for General Category, 08 years for OBC category and 10 years for SC/ST candidates.

4. APPLICATION PROCESS:

Candidates, who are fulfilling the eligibility criteria may fill the application form which will be available at www.aiimspatna.edu.in. After final submission of form, candidates have to take a print of the same, which along with following documents (**original and one set of self-attested copies**) needs to be produced at the time of interview:-

- Date of Birth/SSC/HSSC pass certificate (mentioning Date of Birth)
- MBBS Degree Certificate
- Internship Completion Certificate
- UG/PG NMC/State Registration Certificate
- Category/PwBD Certificate (If seat is claimed in reserved category)
- Experience Certificate, if any
- NOC from present employer (applicable for those working in Govt./Pvt. organization)
- Any other relevant documents (viz. Research Work, Publication etc.)

5. RESERVATION:

- a. The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and **4% for PwBD candidates (on horizontal basis)**.

Persons with Benchmark disabilities (PwBDs) - 4% Horizontal Reservation shall be applicable as per GOI instructions.

Physical requirements for PwBDs- S (Sitting), ST (Standing), BN (Bending), MF (Manipulation by Fingers), W (Walking), SE (Seeing), RW (Reading and Writing), H (Hearing), C (Communication).

Categories of disabled suitable for job- OA (One arm), OL (One leg).

- b. For OBC-NCL Candidates: Candidate(s) must attach certificate valid for the posts under the **Central Government of India** which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 (one) year from the last date of application.
- c. For EWS Candidates: Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does belong to EWS category. Date of issue of Certificate should be from 1 (one) year from last date of application.
- d. For EWS, OBC-NCL, SC and ST – Certificate should be issued by Tehsildar or above rank authorities prescribed by Govt. of India in format of State/Central Government.

8. HOW TO APPLY:

For filling up of online application, candidates must have the following pre-requisites ready:

- Valid E-mail ID and Mobile Number.
- Scanned recent Passport size photograph of candidate (in JPG format).
- Scanned signature of the candidate (in JPG format).
- Online payment detail of the required application fee.
- Aadhar Card.

(b) Guidelines for scanning/uploading the **Photograph, Signature, Date of Birth/SSC/HSSC Pass certificate (mentioning Date of Birth), MBBS Medical Council Registration, MBBS Degree Certificate, Category/PwBD Certificate (if seat is claimed in reserved category), Experience Certificate, NOC (if applicable) & Any other relevant documents (if any) viz. Research Work, Publication etc.**: Before applying online application form, a candidate will be required to have a scanned (digital) image of the above mentioned certificates/documents as per the specifications given below:

i. Photograph (in JPG format):

- Photograph must be a recent of passport size.
- The picture should be in colour, against a light-coloured, preferably white, background.
- Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.
- Dimensions 200 x 230 pixels (preferred)
- Size of file should be between 80 kb–100 kb
- Ensure that the size of the scanned image is not more than 100 KB.

- The applicant has to sign on white paper with Black ink pen.

- Dimensions 140 x 60 pixels (preferred)
- Size of file should be between 50 kb – 80 kb
- Ensure that the size of the scanned image is not more than 80 KB.

iii. Date of Birth/SSC/HSSC Pass certificate (mentioning Date of Birth) (in PDF format):

- Ensure that the size of the scanned image is not more than 1 MB.

iv. UG Medical Council Registration (NMC/State) (in PDF format):

- Ensure that the size of the scanned image is not more than 1 MB.

v. MBBS Internship Completion Certificate (in PDF format):

- Ensure that the size of the scanned image is not more than 1 MB.

vi. Category/PwBD Certificate, where applicable (in PDF format):

- Ensure that the size of the scanned image is not more than 1 MB.

vii. Experience Certificate, if any (in PDF format):

- Ensure that the size of the scanned image is not more than 1 MB.

viii. NOC, if applicable (in PDF format):

- Ensure that the size of the scanned image is not more than 1 MB.

ix. Any other relevant documents (viz. Research Work, Publication etc.) (in PDF format):

- Ensure that the size of the scanned image is not more than 1 MB.

(c) While applying online, in the preview of the form, the candidate's Photo and Signature must be clearly visible to candidate, if photo/signature image is small in size or not visible in preview on website, then it means that the photo/signature is not as per the prescribed format and your application will be rejected. So, be careful while uploading your photo and signature.

(d) Applicants must fill all the fields carefully since after submission of online application, request for change in any information at any later stage will not be considered.

(e) Candidate may access the online application portal by clicking on the link mentioned in the website (i.e. www.aiimspatna.edu.in).

(f) After completing the registration part candidate will receive the user ID and password through E-mail on the registered email address. The same ID and Password shall be displayed on the logged screen. Candidates are requested to note down the User ID and password. Candidates are also advised to take a print of the Registered Application Form for their records and future reference.

(g) The candidates already registered shall click on existing user link and fill the correct user ID and Password for continuing the form filling process. In case of incorrect User ID/Password click on the 'forgot password' link.

(h) The candidates are requested to fill the correct details regarding name/age/sex/caste/address/educational qualification and other relevant fields mentioned in the application portal. Candidates are advised to upload the relevant documents/photographs in the desired format only.

(i) Once the details are correctly filled the candidate may proceed for the fee payment.

(j) Once a candidate clicks on SUBMIT button, a page containing some important instructions for payment, a Payment Reference Number and a Link to make payment of Application Fee will open. Candidates may please note that unless they make the payment



of Application Fee, their application will be treated as INCOMPLETE. Candidates who want to pay at later stage can use this Payment Reference Number for re-login and making the payment in order to complete his/her Registration.

(k) Online payment of fee: Once a candidate clicks on button for making the payment, they will be redirect to the Payment gateway site. There are various options available for payment viz. Internet Banking (major banks) & Debit/Credit Cards. Additional charges viz. bank charges, service tax etc. incurred while making online payment of application fees will be borne by the candidate. After making the successful Payment they will immediately be redirected to (www.aiimspatna.edu.in) for generation of Registered Application Form. Candidates are advised to take a print of the Registered Application Form for their records and future reference. Thus, the process for Registration of candidates who have to pay Application Fee gets completed. The Registration number along with Date of Birth can also be used for downloading the Admit Card prior to the date of examination which shall also be notified in the designated website i.e. www.aiimspatna.edu.in

(I) Once form is submitted, there shall be no provision for making changes in the application form.

(m) Payment of application fees by any other mode viz. Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Executive Director, AIIMS Patna in this regard shall be final and binding.

9. SELECTION PROCESS:

- a) Written test (MCQ based) will be held for selection to the advertised posts of Junior Residents (Non – Academic).
- b) Total Number of questions will be 100, carrying one marks each. There will be no negative marking.
- c) Duration of written (MCQ based) examination will be 01 hours and 30 minutes.
- d) **Qualifying marks for written test will be as under:**
UR: 50 % OBC-NCL/EWS: 45 % SC/ST: 40 %
- e) Final Selection list will be declared solely based on the marks obtained in written examination.
- f) ***While every effort will be made to intimate the candidates regarding Examination schedule at the earliest, the responsibility lies with the candidate to check for the same on the institute website. All Candidates must provide phone numbers and E-mail for faster communication at the time of application.***
- g) The final result will be displayed on the website i.e. (www.aiimspatna.edu.in).

10. METHOD OF RESOLVING TIES:

All Tie cases (more than one candidate having same marks) have been resolved on date of birth. Older candidate (earlier date of birth) is ranked above younger candidate.

11. TERMS OF RECRUITMENT:

- I. Initial appointment of selected Candidates will be for a period of 06 months.
- II. On receiving application from candidate, the tenure may be extended for another six months base on recommendation received from concerned Head of the department and approval received from Executive Director.
- III. After initial appointment a maximum of 01 extension of 06 months may be granted based on fulfilment of criteria mentioned in point no. 02.
- IV. Maximum permissible work period (including initial appointment and 01 possible

extension thereafter) for the post of Junior Resident (Non-Academic) will be 12 (twelve) months. After completing 12 months, no further extension will be given.

12. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

APPLICATION/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/REJECTED SUMMARILY OR AT ANY STAGE OF THE ADMISSION PROCESS IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- i. Applications being incomplete.
- ii. Any variation in the Signatures.
All the SIGNATUREs in FULL (NOT IN SHORT) done on the Print out of the Application Form and also on other Documents must be the same.
- iii. Scanned copy of photograph and signature uploaded are not as per specification given and/or blur or distorted or not clear.
- iii. Non-payment of Examination Fees or non-receipt of fee through online mode, if not otherwise exempted.
- iv. Fee not paid as per instructions.
- v. Under aged/over aged candidates.
- vi. 13. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:
