### TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. The annual extension may be given for twice after a review of the work done on the project during the previous year.
3. **Expiry of Contract:** The contract will automatically expire on completion of 12 months or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
