- For Dentistry only candidates with MDS in conservative & endodontics are eligible to apply.

**5. RESERVATION:**

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 4% for PwBD candidates (on horizontal basis).
- **For OBC-NCL Candidates:** Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from the last date of application.

- c) Written test will be held on **25.01.2026 at AIIMS PATNA only**. Result of the written examination will be declared on 27.01.2026 on AIIMS, Patna website ([www.aiimspatna.edu.in](http://www.aiimspatna.edu.in)).
- d) **Qualifying marks for written test will be as under:**

- e) The successful candidates {maximum three (03) times of seats in each speciality} will be called for the personal interview to be conducted on 29<sup>th</sup>, 30<sup>th</sup> & 31<sup>st</sup> January 2026. Total marks of interview will be **of 20 Marks**.

- x. Selected candidates must join the institute within the stipulated date as mentioned in the offer of appointment letter, failing which the selection shall stand cancelled/ withdrawn.
