4. The Competent Authority, AIIMS Patna reserves the right to increase, decrease, withdraw or modify the number of vacancies and/or the recruitment process without assigning any reason.

Eligibility Criteria

1. The candidate must possess the prescribed postgraduate qualification in the concerned specialty/discipline from a recognized University/Institute.
2. The candidate must be registered with the National Medical Commission/State Medical Council, wherever applicable.
3. The candidate should fulfil all eligibility conditions as prescribed under the applicable Residency Scheme.
4. Candidates who are already working in any Government/Autonomous Institution shall be required to produce a **No Objection Certificate (NOC)** from their employer at the time of interview/document verification.

Upper Age Limit

1. For eligibility to apply for these posts upper age limit as on 31.08.2026 will be 45 years. This is relaxable for SC/ST candidate for a maximum period of Five years. In the case of OBC candidates it is relaxable up to maximum period of Three years. In case of Persons with Disabilities (PwBD) candidates, this is relaxable up to maximum period of Ten years for General category, Thirteen years for OBC category and Fifteen years for SC/ST category candidates.
2. The candidates who have already completed the maximum permissible period of Senior Residency under the applicable Residency Scheme/rules shall not be eligible for appointment to the post.
3. To be able for selection for these posts, the candidate should pass the qualifying examination by 31st July, 2026 and should be declared to this effect on or before this date.
4. The candidates who are in service in any Government Institutions are required to submit No Objection Certificate from the employer at the time of interview/at the time of joining.

Pay and Allowances

Senior Resident will receive salary plus other allowances as per the 7th CPC (level-11 of the matrix Pre-revised PB-3, entry pay of the Rs. 67,700/- per month+ NPA+ other allowances as admissible under rules) as applicable under govt. of India Rules.

RESERVATION FOR SC/ST/OBC/PwBD/EWS SHALL BE APPLICABLE AS PER GOVT. OF INDIA POLICY.

Candidates applying under the EWS/OBC/SC/ST category must possess a valid category certificate issued by the competent authority in the prescribed format and valid for admission/employment in Central Government Institutions, issued on or before the date of interview. In the absence of a valid reserved category certificate, a candidate may be considered against an Unreserved (UR) vacancy, provided that the post has been advertised under the UR category and the candidate fulfils all eligibility criteria prescribed for UR candidates.

Further, in case of OBC/EWS candidates, the certificate must have been issued during the Financial Year 2026-27.

Criteria for Persons with Disabilities Candidates:

Reservation for Persons with Bench-mark Disabilities Candidates (PwBD) is applicable by Govt. of India Policy, which will be provided on horizontal basis to PwBD candidate in their respective categories.

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions and countersigned by Medical Superintendent/CMO/Head of Hospital/Institution.

Candidates are advised to report within the prescribed reporting time for registration and document verification. No candidate may be allowed to appear in the interview after the stipulated reporting time.

Selection Procedure

Selection shall be made on the basis of:

1. Verification of eligibility and original documents; and
2. Selection shall be made on the basis of performance in the walk-in-interview, subject to fulfilment of the prescribed eligibility criteria, verification of original documents and applicable reservation rule.
3. In case of a tie between two or more candidates securing equal marks, the candidate older in age, i.e. having the earlier date of birth, shall be placed higher in the merit.
4. Performance in the interview and/or any other selection process, as decided by the Competent Authority.

The decision of the Competent Authority/Selection Committee shall be final and binding.

11. Valid OBC (Non-Creamy Layer) certificate/EWS certificate, wherever applicable.
12. PwBD certificate, wherever applicable.
13. No Objection Certificate (NOC), if employed in any Government/Autonomous Institution.
14. Publications and other relevant documents, if any.

Candidates failing to produce the required original documents at the time of verification may not be considered for the interview/selection.
