TERMS & CONDITIONS:

1. It is candidate's responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. 3. **Expiry of Contract:** The contract will automatically expire on completion up to **31-03-2026** or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 day's notice or salary in lieu thereof.
