Persons with Benchmark disabilities (PwBDs) - 4% Horizontal Reservation shall be applicable as per GOI instructions.

Physical requirements for PwBDs- S (Sitting), ST (Standing), BN (Bending), MF (Manipulation by Fingers), W (Walking), SE seeing), RW (Reading and Writing), H (Hearing), C (Communication).

Categories of disabled suitable for job- OA (One arm), OL (One leg).

Note: Vacancies may increase or decrease at the time of selection with approval from competent authority. The number of vacancies indicated as above are provisional and subject to change without any prior notice.

1. QUALIFICATION:

- Post Graduate Degree i.e. MD/MS/DNB/DM/M.Ch or equivalent in the above Departments recognized by Medical Council of India / NMC/ NBE.
- For Clinical Haematology seats candidates with MD in General Medicine and MD in Paediatrics will also be considered.

2. AGE LIMIT:

The upper age limit for applying these posts is 45 years.

Cut-off date to determine eligibility in terms of age of candidates will be the date of walk-in interview. SC/ST/OBC/PWBD candidates who opt to apply for unreserved vacancies will not be eligible for age relaxation otherwise allowed to those belonging to these categories. Further, reserve category candidates (SC/ST/OBC/PWBD) who become eligible by virtue of age relaxation applicable in their category will be considered only for reserved seats of the category to which they belong even if they have the merit to be considered otherwise for UR.

Age relaxation is permissible to various applicants is as under: -

- SC/ST- 5 years
- OBC - 3 years
- PWBD- 10 years
- Ex Servicemen Candidate- 5 years.

3. APPLICATION FEES & MODE OF PAYMENT:

- General/OBC Category : Rs 1500/-
- SC/ST/EWS Category : Rs 1200/-
- Ex-servicemen/Women/PwBD candidate is exempted from any fee.

Application fee is required to be remitted through Demand Draft only. The **Demand Draft should be drawn in favour of AIIMS, Patna payable at AIIMS, Patna.** Any other instrument of payment is not acceptable. The application fee is non-refundable.

4. FILLING UP OF APPLICATION FORM ON THE DATE OF WALK-IN INTERVIEW:

- For filling up of application on the date of walk-in interview, the candidates have to bring the following documents (**original and one set of self-attested copies**) which also needs to be produced at the time of walk-in interview:-
 - Recent Passport size photograph of candidate where face is clearly visible
 - The picture should be in colour, against a light-coloured, preferably white background
 - Caps, hats and dark glasses are not acceptable. Religious headwear is allowed but it must not cover your face.

5. RESERVATION:

- The reservation for EWS/OBC-NCL/SC/ST candidates is as per Central Govt. rules and 4% for PwBD candidates (on horizontal basis).
- **For OBC-NCL Candidates:** Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does not belong to Creamy Layer. Date of issue of Certificate should not be earlier than 1 year from date of walk-in interview. Candidate must submit the OBC certificate issued by the competent authority of Govt. of India in Format given by DOPT/ Govt. of India or for the appointment to the Central Government Job.
- **For EWS Candidates:** Candidate(s) must attach certificate valid for the posts under the Central Government of India which mentions that the Candidates does belong to EWS category. Date of issue of Certificate should not be earlier than 1 year from date of walk-in interview.
