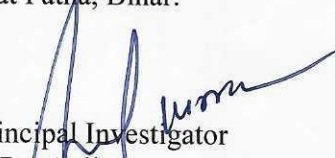
Selection Process:- Interview.

The above post is to be filled purely on contract basis for a period of one year. The annual extension may be given for twice after a review of the work done on the project during the previous year. The candidates willing to apply may visit the institute's website i.e. www.aiimspatna.org for detail information. Eligible candidates may apply on the attached proforma. **Send the scanned copy of filled up application form along with supporting documents via e-mail to dranilk@aiimspatna.org & deanresearch@aiimspatna.org** (Must be sent on both e-mail id' in one mail, not separately). Last date for receiving the application at AIIMS Patna is **within 15 days** from the date of advertisement. Eligible candidates will be called for Written Test & interview through notice on institute's website. No separate call letters will be sent to the eligible candidates for appearing in the interview. Hence, it is candidate's responsibility to visit the institute's website from time to time.



TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. If any declaration given or information furnished by him/her proves false or if he/she is found to have willfully suppressed any material or information, he/she will be liable for removal from service and also such other action as the Government may deem necessary. Even after qualifying in the selection process the candidate may be rendered disqualified at the time of document verification if he/she does not fulfill essential eligibility criteria.
2. **Tenure:** The assignments are purely on contract basis for a period of 12 months (At every 3 months recommendation of PI is necessary to get continuous appointment). These appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS, Patna/ICMR or continued contractual appointment. The annual extension may be given for twice after a review of the work done on the project during the previous year.
3. **Expiry of Contract:** The contract will automatically expire on completion of 12 months or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. **Leave:** The leave entitlement of the appointee shall be governed in terms of the DHR/ICMR leave policy as amended from time to time.
5. **Accommodation:** No hostel or any other accommodation will be provided by the institute.
6. Canvassing of any kind will lead to disqualification.
7. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
8. The appointment is full time and private practice of any type is prohibited.
9. The research project for which contractual appointment is being done requires office work and field visits.
