Executive Director, AIIMS Patna gave a brief note of the Action Taken Report (ATR) to the GB, during which he highlighted few important points as mentioned below:

- With a sanctioned seat of 20, the Allied Health Sciences course has been started at AIIMS Patna from the session 2024-25. A total of 16 admission took place in the first year.

- GB was also informed about functioning of Eye Bank & Corneal transplant since July 2025.
- Also informed about starting of Liver Transplant facility in the institute very soon in 2025.

Ratification of the Approval of the selection of 2 Independent External Monitors at AIIMS Patna.

Governing Body noted and ratified the selection of Two (02) Independent External Monitors (IEMs) namely Shri Arun Chandra Verma, IPS (Retd.) and Shri Seshagiri Rao Annangi at AIIMS Patna by Central Vigilance Commission, New Delhi. Further, it was decided by the Governing Body that in the forthcoming standing finance committee meeting the ceiling for tenders regarding integrity pact and monitoring by IEMs may be raised from Rs. 1 Crore.

The minimum duration of service required for issuance of NOC to both faculty and Non-Faculty in the institute.

Governing Body decided that, henceforth, all intimations and requests for NOCs for outside employment shall be treated as request for NOC and NOC shall be issued irrespective of the completion of probation period. However, a ceiling of 04 (Four) requests per calendar year shall be imposed. Intimations regarding applying against selections advertised by UPSC shall not be counted amongst this ceiling of four requests per calendar year as per DoPT guidelines. Further, it was decided by Governing Body that the minimum duration for issuance of NOC for both Faculty and Non-Faculty in the institute would be six months after joining.

Presentation regarding the status of case against Prof. (Dr.) G K Pal, former Executive Director of AIIMS Patna.

The Governing Body took note of the fact that Prof. (Dr.) G K Pal, former Executive Director of AIIMS Patna was prematurely repatriated to the parent cadre JIPMER, Puducherry with the prior approval of the Appointments Committee of the Cabinet (ACC) and Hon'ble HFM vide order dated 24.12.2024. Thereafter, all the documents and records pertaining to the disciplinary proceedings of Dr. G K Pal had been forwarded to the admin office of JIPMER for further needful. It is apparent that no action in the present case is pending on the part of the institute.

Governing Body noted the updated status of the aforesaid case.

Matter related to Dr. Kumar Siddharth, Assistant Professor, Physiology.

Governing Body considered the various developments chronologically in the matter related to Dr. Kumar Siddharth, Assistant Professor, Physiology. It is pertinent to note that as per the legal inputs furnished before the Governing Body, it was recommended that in the present case the procedure provided under rule 14 of the CCS (CCA) Rules, 1965 for imposition of major penalty is required to be complied with by issuing Article of Charges alongwith other requisite documents. Further, it was recommended that if the delinquent official does not attend the proceeding then the proceedings may be proceeded ex-parte.

In view of the above, it was decided by the Governing Body that disciplinary proceedings under Rule 14 of the CCS (CCA) Rules, 1965 be initiated in the present case and the endeavor should be to finish the proceedings at the earliest, maximum within 3 months. Further, the Governing Body directed the Screening Committees for document verification to be more vigilant and observant so as to avoid scenarios like the present case.

Matter related to Prof. (Dr.) Prem Kumar, Former Dean (A) and Dean (R) of the institute.

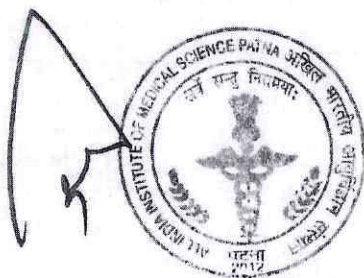
Governing Body took note of the matter in (chronological order) and detailed legal opinion furnished in the present case wherein it was recommended that in the light of the judgment dated 19.11.2024 of Hon'ble Supreme Court in State Bank of India & Anr. Vs Navin Kumar Sinha, Section 4(6) of the Payment of Gratuity Act, 1972, Rule 8(1) of CCS Pension Rules, 2021 and Rules 39(3) of the Central Civil Services (Leave) Rules, 1972, the amount of Gratuity and Leave Encashment kept in abeyance may be released to Prof. (Dr.) Prem Kumar.

In view of the above, it was decided by the Governing Body that the pending leave encashment as well as gratuity to Dr. Prem Kumar, Former Dean (A) and Dean (R) be released.

Governing Body after taking into consideration the various developments in the case decided to approve the draft Charge Sheet. Further, it was pointed out by the Hon'ble Governing Body that the disciplinary proceedings in the present case should be completed at the earliest, maximum within 3 months.

Governing Body after taking note of the fact that two meetings with National Commission for Backward Classes (NCBC) were held on 28.03.2025 and 27.06.2025. In both the meetings, NCBC had categorically pointed out serious shortcomings in the OBC NCL certificates of the students, faculties and non-faculties recruited by the institute.

In view of this, after taking into consideration the Governing Body decided that a letter in this regard be issued to the concerned officials for providing clarifications regarding any mismatch of details or issuance of the respective OBC certificates failing which disciplinary proceedings need to be initiated.

Any other issues with the permission of Chair.

1. Governing Body decided to recommend to Institute Body to adopt the AIIMS Regulations dated 18.10.2019 in totality since 18.10.2019 and to grant ex-post facto approval for regularization of all the actions and decisions taken by the office bearers/authorities/bodies of AIIMS Patna in accordance/compliance with the AIIMS Regulations dated 18.10.2019 since then.
2. The case of Dr. Alok Ranjan, Assistant Professor, Department of Community & Family Medicine was presented before the Hon'ble Governing Body.
 - The Governing Body took note of the inquiry report submitted by Prof. (Dr.) D. K. Singh, Executive Director, AIIMS, Bhatinda cum the Inquiry Officer, AIIMS, Patna to enquire into the article of charge pressed against Dr. Alok Ranjan, Assistant Professor, Department of Community and Family Medicine, AIIMS, Patna, vide No. FTS-81162/DISC-CASE/2021, Dated 26-05-2021 issued by the President, Institute Body, AIIMS, Patna. The said inquiry report was also presented during the 8th Institute Body meeting held on 28.11.2023. The relevant finding of the report has been reproduced as under for perusal:

Conclusion: - As the AIIMS Patna has accepted that Search-cum-Selection Committee has gravely erred in recommending the name of Dr. Alok Ranjan for his appointment and this committee has no scope to inquire the role of Search-cum-Selection Committee Members. As the general principle of the justice the candidate should not suffer even if the Search-cum-Selection Committee has done error.

- The Governing Body took note of the aforesaid conclusion of the report of the Inquiry Officer, Prof. (Dr.) D. K. Singh.
 - The crux of the allegation revolved around the fact that Dr. Alok Ranjan was not possessing the relevant educational qualification during the time of his appointment on 07.9.2012 as Assistant Professor in the Department of Community & Family Medicine.
 - The Governing Body took note of the fact that Dr. Alok in his application form had indicated that he was enrolled as a Ph.D Candidate in epidemiology in the University of California in 2004 whereas as per the documents submitted by Dr. Alok, he had completed his Ph.D. on 14.06.2013.
 - In view of the above findings, in the present case it was decided by the Governing Body that special Standing Selection Committee (SSC) may be held on priority for holding DPC (Departmental Promotion Committee) in the present case. Further, with regard to the present case the Governing Body was of the view that eligibility period for promotion to be considered w.e.f. 14.06.2013 instead of 07.09.2012. This is the rare case and not to be quoted as precedent for all the cases.
3. The Governing Body also directed that equipments related to robotic surgery be procured by the institute at the earliest for essential patient care.
 4. Prof. (Dr.) R K Dhiman, President, AIIMS Patna also pointed out that institute should endeavor to start Research Day and Alumni Day so that the research facilities are strengthened by celebrating the research achievements of the faculties of the Institute.


The action taken report on the minutes of the 5th GB held on 05th August, 2023 was approved by the Hon'ble Governing Body.

Report regarding the Mission Recruitment undertaken by AIIMS Patna.

The Member Secretary informed the Hon'ble Members of the Governing Body that AIIMS Patna has undertaken the Mission Recruitment of Ministry of Health & Family Welfare on a mission mode to fill-up 2120 vacant posts at AIIMS Patna. The non-faculty recruitment for 640 posts was undertaken vide advertisement no. F-126282/Rect./Non-Faculty/2023 dated 26.04.2023 and TCS has been appointed as the executing agency for Non-faculty recruitment. Overall 6 phases of examination were undertaken on 19.08.23, 27.08.23, 2.09.23, 3.09.23, 16.09.23, 23.09.23 and 23.11.23 for 540 posts. The Member Secretary informed that the examinations for the remaining posts shall be held on 28.11.23 &

30.11.2023. AIIMS Patna created a unique Control Room at its premises to closely monitor the smooth conduct of all the examination for the non-faculty posts.

In addition, 93 faculty posts were advertised vide Rolling advertisement number 2023/1 Dated: 11.09.2023 and the selection of the said 93 posts were done by the Hon'ble Standing Selection Committee (SSC) from 6th to 9th Nov., 2023. Also, advertisements have been released for recruitment of 20 vacant posts of Nursing Tutors/Instructors and 93 posts of Senior Residents to be recruited on regular basis.

Member Secretary, Dr. G.K. Pal informed the Hon'ble GB that AIIMS Patna has taken a lead in both the Faculty and Non-faculty recruitments ahead of other AIIMS, which has been highly appreciated at the Ministry level. Out of 2120 vacant posts, AIIMS Patna has already completed the recruitment of 1738 posts. Currently only 382 posts are remaining vacant at AIIMS Patna which will be filled in the month of December and the target of filling 2120 posts will be achieved by end of December, as the deadline given by the Ministry for completion of recruitments.

The Chairman & all the members of Hon'ble GB highly appreciated the efforts of Executive Director and his entire team at AIIMS Patna for successful conduct of Mission Recruitment of AIIMS Patna.




Ratification of Minutes of 8th Meeting of the Standing Academic Committee held on 24th November, 2023



- The Hon'ble SAC accorded in principle approval for utilisation of AIIMS Patna fund for intramural funding for projects of Undergraduates, Post-Graduates & PhD students. The proposal will further be placed before SFC for approval of financial implication.
- The implementation of part-time PhD program of faculty/tutors of College of Nursing was considered and approved with few recommendations as noted in the minutes of SAC.
- The Hon'ble SAC approved the proposal for starting the unit of Endocrine Surgery under the Department of General Surgery.
- The Hon'ble SAC approved the starting of new DM (3 years) course in Interventional Radiology.
- In-principle approval for starting 6 new MSc. Nursing Courses at AIIMS Patna was given during the 8th SAC. However, SAC directed that there should be at least two Faculty in each speciality of the corresponding courses/subjects, before the courses are advertised for the admission of students.

Decision:

The Hon'ble GB ratified and approved the Minutes of 8th Meeting of the Standing Academic Committee held on 24th November, 2023. However, the GB directed following points for further improvement in the academic programs of the Institute.

In addition to the criteria of eligibility of Faculty to become PhD guide, the guide should have extramural funded projects also for the internal PhD fellowships, the feasibility and sustainability report of the guide, and a synopsis of the proposed research project for the PhD student prepared by the guide to be submitted for evaluation by an expert committee under the chairmanship of ED, AIIMS Patna, there should be two PubMed indexed publications before submission of PhD thesis, and the PhD thesis should be evaluated by three experts consisting of two subject experts from India and one subject expert from abroad.
 - iv. For the proposal of deputing Nursing Officers for studying MSc. Nursing Course outside the institute, only for the courses that are not available at AIIMS Patna and if there is a clear need by the institute for pursuing such a course, will be followed.



1. The Hon'ble High Court has confirmed quashing of suspension order and subsequent suspension order and has also quashed charge memo issued by Director without approval of appropriate Authority.
2. The Hon'ble High Court has expunged the comments made by Hon'ble CAT Patna in Para 24 of their order dated 01.02.2023.
3. The Hon'ble High Court has directed AIIMS Patna to regulate the suspension period of Dr. Sailesh Mukul as on duty while calculating difference of salary and disbursing the same within a period of 3 months from the date of receipt of this order.
4. The Hon'ble High Court has given liberty to AIIMS Patna to initiate Inquiry against Dr. Sailesh Mukul afresh and in accordance with relevant provisions. The Court has directed to initiate and conclude the same within six months from the date of receipt of this order.

Prof. Dr. G. K. Pal, Executive Director, AIIMS Patna and Member Secretary of the Governing Body of AIIMS Patna welcomed the Chairman and all the Members of the GB to the 4th Meeting of the Governing Body of AIIMS Patna.

In his welcome note, Dr. Pal extended a warm greeting to the Chairman and the Members of GB for being physically attending the meeting in spite of prevailing cold weather and in spite of their busy schedules. He requested the Chairman to give his opening remarks before the Meeting is conducted as per the Agenda items.

The Hon'ble Chairman Dr. N. K. Arora welcomed all the members and he informed that this meeting is being conducted after a gap of almost 2 years. He expressed his satisfaction regarding various developmental works taken up by the new Executive Director, especially the recruitment of JRs, SRs, Nursing Staff and Faculty Members. He informed that the Rolling Advertisement initiated by the Executive Director, AIIMS Patna has become a model of advertisement for faculty recruitment among all INIs and many new faculties have been selected for AIIMS Patna through this Rolling Advertisement. Dr. Arora informed that the Chairman, SSC, Dr. Subrata Sinha has also personally conveyed him about the robust procedure adopted for selection of faculty based on their merit and performance in the interview. Prof. N. K. Arora congratulated the Executive Director for his sincere and hard work in the conduct of interview in a methodical way and publication of results in a record time of three days, which has set an example of an ideal way of conducting SSC Meetings of the Faculty Recruitment.

Confirmation of the Minutes of the Third Governing Body meeting held on 18th February, 2021

Decision:

The proposal to start a Department of Clinical Psychology & Behavioural Sciences should be placed before the Standing Academic Committee (SAC) in its next meeting. Also, it was decided that two posts of Clinical Psychologists should be created in the said department. The Hon'ble Chairman informed that Organ Transplantation should be started at AIIMS Patna. In addition to Kidney Transplantation, the transplantation of Liver and Bone Marrow should be initiated at the earliest at AIIMS Patna.

The Executive Director informed that in the last 6th SAC Meeting held on 16th December, 2022, he has already got the approval from the SAC to initiate PhD admission at AIIMS Patna with the Intramural Funds available for the programme and also to make the PhD programme a vibrant one. The Executive Director also informed that the process of getting organ transplantation has been taken up in a big way, and kidney transplantation programme is in the pipeline. The process of Liver and Bone Marrow Transplantation will also be taken up soon.

The Hon'ble Chairman informed that faculty leaving the AIIMS to join the new AIIMS has become a problem at all AIIMS. He opined that we should have a mechanism not to allow the faculty for at least 5 years after their joining the post to apply for other institutes including AIIMS. It was decided to have a uniform policy on this issue, the matter should be taken up in CIB meeting to be held on 8th Jan, 2023 at AIIMS Bhubaneswar.

The Minutes of the meeting of HR Sub-Committee of IB/GB held on 14th Nov, 2022 was approved and ratified by the Hon'ble GB. This HR Sub-Committee was conducted to give approval for the result of 5th SSC for APS Promotion and for Direct Recruitment.

The Hon'ble Chairman wished to know the cause of four faculty not being promoted through APS. The Executive Director informed that the performance of these faculties in the Interview was not satisfactory. Moreover, their APARs scoring was not good. The Executive Director also informed that two faculties (one in General Surgery and the other in Pulmonary Medicine) are not regular in attending their hospital duties both in OPD and IPD. The Head of the Departments of these two faculties have already given in written to the Executive Director of their negligence in the duty, and ED during his Hospital rounds has often noted the absence of these faculties in OPD and other hospital duty-areas. After a thorough

discussion, it was decided that these faculties, who are negligent of their duties should be given show-cause notices and disciplinary action should be initiated against them.

The Executive Director also informed that there was problem in promotion of Dr. K. K. Sharma, who had applied for promotion to the post of Additional Professor in the Department of Neurosurgery, which has been listed for discussion in GB as a separate Agenda item (vide Agenda Item No. GB-04/15/2023). The Executive Director also informed that there was also problem in the promotion of Dr. Minakshi Tiwari through APS from Associate Professor to Additional Professor of Pathology, which has also been listed for discussion in GB, vide Agenda Item No. GB-04/16/2023. The Executive Director further informed that there is a case of Contempt of Court against the Executive Director, AIIMS Patna by Dr. Neha Singh as she was not listed for interview for the post of Assistant Professor of Transfusion Medicine and Blood Bank and the same has been listed as separate Agenda Item (vide Agenda No: GB-04/17/2023) for discussion.

Directions sought on the APS Application of Dr. K. K. Sharma, Associate Professor, Department of Trauma and Emergency for promotion to Additional Professor, Department of Neurosurgery

Decision:

The Executive Director informed that Dr. K. K. Sharma, who appeared for promotion to the post of Additional Professor in Neurosurgery had objections from the subject experts that he has not worked in the Department of Neurosurgery during the assessment period. Therefore, the Standing Selection Committee (SSC) had decided to place the matter before the GB for direction on the matter. The matter was discussed at length and GB uphold the decision of subject experts in not allowing Dr. K. K. Sharma's promotion to the Additional Professor of Neurosurgery as he has not worked in that department during the assessment period. The Executive Director suggested that as Dr. K. K. Sharma has worked during the four years of assessment period in Trauma & Emergency, he may be considered for promotion to the post of Additional Professor Trauma & Emergency. The suggestion of Executive Director was accepted by GB and it was decided that Dr. Sharma may appear before the SSC in its next meeting, which is likely to be held in the middle of February, 2023, and he will be assessed by subject experts in Trauma & Emergency.

Direction sought on the result of Dr. Meenakshi Tiwari for APS from Associate Professor to Additional Professor, Department of Pathology/Lab Medicine

Decision:

Dr. Meenakshi Tiwari, Associate Professor of Department of Pathology and Lab Medicine appeared for Interview for the post of Additional Professor in Pathology and Lab Medicine. The Executive Director informed that both the Subject Experts had strong objections to her promotion as she doesn't have the basic educational qualification of MD in Pathology. They were of the opinion that a Faculty having MSc. and PhD Degree in Environmental Biochemistry can't be given promotion to the post of Additional Professor in Pathology. Therefore, the SSC had referred the matter to Governing Body for further discussion and direction. After a thorough discussion, the GB accepted the opinion of the subject expert⁵ that a faculty without having postgraduate qualification in a subject can't be promoted to Additional Professor in that subject. The Executive Director informed that Dr. Meenakshi Tiwari is good in Research and she can be accommodated in the Advance Center of Research, which will be established soon at AIIMS Patna. However, till the Research Center is established, ED proposed that as Dr. Meenakshi Tiwari has MSc. and PhD degrees in Environmental Biochemistry, she can be involved in research and training in Biochemistry as a faculty, and in the next APS promotion, she may be allowed to appear for promotion to the Post of Additional Professor of Biochemistry (with retrospective effect). The proposal of Executive Director was accepted by GB, and it was decided that Dr. Meenakshi Tiwari will be shifted as a faculty to the Dept. of Biochemistry, and later to the Advance Centre of Research as and when the centre will be established.

Intimation and Discussion of "Contempt of Court" against ED, AIIMS Patna by Dr. Neha Singh, Blood Transfusion Officer for not being shortlisted for Assistant Professor in the Department of Transfusion Medicine and Blood Bank and Ratification of President's approval of engaging Additional Solicitor General as the counsel for AIIMS Patna

Executive Director informed that Dr. Neha Singh, Blood Transfusion Officer, AIIMS Patna who had applied for the post of Assistant Professor in the Department of Transfusion Medicine & Blood Bank was not-eligible for the subject as she was not having MD degree in

the subject (she has MD degree in Pathology). Dr. Neha Singh filed an O.A. No. 823 of 2022 before Hon'ble CAT, Patna on 03.11.2022, wherein inter alia she had prayed for interim relief to allow her to appear in interview for the post of Assistant Professor in the Department of Transfusion Medicine & Blood Bank, AIIMS Patna to be held on 12.11.2022.

The said O.A. under reference was heard by the Hon'ble CAT Patna on 04.11.2022 and also on 09.11.2022. The Hon'ble CAT Patna vide Order dated- 09.11.2022 directed the Respondents to consider and pass a reasoned and speaking order upon the representation dated 13.10.22 of applicant at the earliest possible and communicate the same to the applicant. However, the order was lengthy and unclear to the administration. Therefore, Shri B. K. Pandey, Senior Advocate, representing the case in Hon'ble CAT was requested to clarify the issue. Accordingly, the entire issue was presented by Shri B. K. Pandey before the SSC to give his views on 11.11.2022, and as per his inputs and advice, the speaking and reasoned order was passed by ED AIIMS Patna rejecting her candidature on 10.11.2022. Consequently as per advice of Shri. B. K. Pandey, Advocate, Dr. Neha Singh was not allowed to appear for interview scheduled on 12.11.2022. Subsequently, Dr. Neha Singh filed a Contempt of Court case against the ED, AIIMS Patna for alleged non-compliance of the Order dated 09.11.2022 of Hon'ble CAT Patna in the O.A. under reference.

Decision:

The GB after thorough discussion and after getting inputs from the legal advisor, Mr. B. K. Pandey, approved the proposal of engaging ASG for obtaining clarification on the issue of contempt, whether AIIMS has erred in its interpretation and the contempt of court has been made, and also to engage ASG as the Counsel to defend the case of Contempt of Court filed by Dr. Neha Singh in Hon'ble CAT, Patna.

This will provide the best of the treatment for the cardio-vascular and cerebro-vascular accidents. He wished that the Executive Director takes initiative in taking this proposal to the next Standing Academic Committee and Standing Finance Committee for approval. Prof. Arora also informed that the Critical Care facility at AIIMS Patna should be strengthened by establishing state of the art Emergency Medicine Block with the best of the facilities available in Emergency Medicine.

Members wished to know why the appointment of M.S. has not been initiated though the tenure of the present M.S. is over and he is working more than one and a half years beyond his completion of the tenure. The Executive Director informed that the M.S. post was advertised for recruitment on deputation basis, but no suitable candidates were available for the post. He further informed that he will be re-advertising the post of M.S. and he is also trying to have a M.S. on deputation basis from a renowned Institutions like AIIMS Delhi, PGI Chandigarh or JIPMER Puducherry. The Members expressed their happiness for creation of new DM/MCH courses in Cardiology, Neonatology, Nephrology, Clinical and Interventional Physiology and Urology at AIIMS Patna. Members expressed huge appreciation for starting the Clinical and Interventional Physiology which will be a new of its kind in the entire country and will create a lot of opportunities and scopes for linking Physiology with Medicine.

Members also agreed that the proposal for starting the Department of Endocrine Surgery and bifurcating the Department of Trauma & Emergency into Department of Trauma Surgery (for MCh course) and Department of Emergency Medicine (for MD course). The Hon'ble GB appreciated the proposal of Institute funded PhD programme and wished the Executive Director to make the PhD programme a very robust one. The GB also appreciated the initiative to introduce the programme of Dual Degree Course of Hospital and Health Care Management to be initiated as proposed by IIM, Bodh Gaya in collaboration with AIIMS Patna.

Seeking decision regarding recommendation of the High Level Committee.

The 5th Institute Body Meeting vide its Agenda Item No: IB-05/09/2020 decided that the Governing Body will take decision regarding the recommendation of the High Level Committee and give back its decision to the Institute Body.

In this regard relevant documents i.e. High Level Committee Report and Committee nominated by the President were sent by post/e-mail to all the members of the Governing Body.

Decision sought:

As per the direction of the 5th Institute Body. The Governing Body to decide about the irregular appointment of faculty members recommended by the High Level Committee and by the Committee nominated by the President.

Discussion:

During discussion **Shri Sanjay Jaiswal** wanted to know about the matter of Shri Bheem Prasad from the Director, AIIMS Patna Dr. P. K. Singh.

Director P. K. Singh informed that Shri Bheem Prasad was appointed as a Senior Resident at AIIMS Patna and after completion of his tenure he was relieved from Senior Residency. Shri Bheem Prasad filed a case in Court seeking relief contending that he was not given appointment at AIIMS Patna as Assistant Professor. The case was decided in favour of Bheem Prasad in CAT and High Court. Thereafter, the Ministry filed a SLP in Supreme Court. The Supreme Court has stayed the order of the High Court.

Shri Sanjay Jaiswal asked to the Director, was Dr. Bheem Prasad appointed as a Senior Resident and got the salary of the same.

Director AIIMS, Patna informed that Dr. Bheem Prasad was appointed as a Senior Resident and he got the salary of the same.

Shri Sanjay Jaiswal further queried, then how he won the case in both the CAT and High Court?

To which **Director AIIMS Patna** informed "I have no idea how he won the case"

Shri Sanjay Jaiswal further queried why AIIMS was interested in appointing doctors which were from non-medical background even if they were from Zoology, Industrial Biochemistry and have been working for last eight years, and on the other hand a doctor who had a degree of post-graduate was terminated. And on the other hand three Committees had said that the appointment of faculties was done irregularly even though you have not terminated them. He also said that something wrong -doing is happening since last 8 years, then why are you not taking any action and how will the

financial lossess incurred upon the Institute, be recovered. What will be the mode of the recovery and from whom and when will it be recovered.

Director, AIIMS Patna informed that Dr.Bheem Prasad was appointed as Senior Resident, and as far as the appointment and termination of the Senior Resident is concerned, the Authority rests with the Director of the Institute. Whereas, as far as appointment and termination of the Faculty is concerned, the authority rests with the Governing Body as per the Act of the Institute. The post of Senior Residency is of tenure based and after completion of tenure, Dr.Bheem Prasad was supposed to be relieved, as his tenure was complete.

Shri Sanjay Jaiswal further said that after the matter came to light AIIMS Bhuneshwar and AIIMS Rishikesh had taken action against the irregular appointments regarding non-medical background doctors, and whereas AIIMS, Patna, which was directly involved with the matter of irregular appointments, had not taken any action and prolonging it. Questioning why it is so.

Director, AIIMS Patna further informed that AIIMS Patna has sent notices to all those, who were found appointed irregularly in the Arya Committee. Some of the faculty went to Court and thereafter Ministry formed a High Level Committee to look into the matter. The High Level Committee in its report found that some appointments were correct, and some were irregularly done. This report was submitted to the Ministry and then the Ministry directed us to take this decision into Institute Body to take a decision and this is being discussed in the Governing Body in pursuance to it.

Shri Sanjay Jaiswal quoted why responsibility is not being fixed and why the matter is prolonging. He said that we should fix responsibility for this wrong doing, he requested the president Institute Body to look into this matter and take some decision on this matter.

Director AIIMS Patna narrated to the Governing Body about the sequences of events and the actions taken in this regard so far.

- A. Arya committee was appointed to look in to the alleged irregular appointment of faculty member at AIIMS Patna during year 2012-13.
- B. Based on the Arya committee report, the Ministry of Health & Family Welfare asked the AIIMS to issue show-cause notices to these irregularly appointed faculty members leading to termination of their services.
- C. AIIMS served the show cause notices to those faculty member whose name appeared in the Arya Committee report as irregularly appointed.
- D. Some of the faculty members, who were served show-cause notice, moved to CAT.
- E. Meanwhile Ministry of Health and Family Welfare constituted another Committee namely High Level Committee to review the Arya Committee

report owing to Court cases and representation received against the show-cause notices served.

- f. High Level Committee report was discussed in the 3rd, 4th and 5th Meeting of Institute Body.
- g. On the direction of Ministry of Health and Family Welfare the president constituted the two member Committee comprising of Dr. Saurabh Varsney, Executive Director, AIIMS Deoghar and Dr. N. R. Biswas, Director, IGIMS Patna to provide opportunity of personal hearing to all those faculty member whose appointment were found irregular.
- h. Institute Body in its 5th Meeting directed the Governing Body to take a decision regarding the recommendations of the High Level Committee, and give its decision to Institute Body.
- i. AIIMS has circulated all the documents related to the issue of the every member of Governing Body.

Following are the important decision taken by the different Committees:

1. The High Level Committee after reviewing the recommendations of the Arya Committee in the background of the documents made available, reported the names of Prof. Ajeet Kumar Saxena, Dr. Sushmita Das, Dr. Alok Ranjan, Dr. K. K. Sharma and Dr. Meenakshi Tiwari as an irregular appointments.
2. The Committee appointed by the President to provide personnel hearing to all these aggrieved faculty member, opined that there are no irregularities in the appointments of Dr. K. K. Sharma and Dr. Meenakshi Tiwari.

Director, AIIMS Patna informed that first action that is required is, "do we accept the recommendations of the High Level Committee or we do not accept it?" If we accept this that means the names of which the Committee finds eligible for appointment is acceptable. At the same time, that also means that the names which Committee finds not eligible for appointment is also accepted. So, that means we approve all those appointments which were held found eligible by the High Level Committee is approved. It also means that all those found non-eligible by the High Level Committee that is also acceptable to the Governing Body. So, these are two broad issues that are to be decided.

Shri Sanjay Jaiswal queried that why the High Level Committee found two people eligible, who were not eligible in the Arya Committee report. He wanted Director AIIMS Patna to put forth a detailed report within four days.

Dr. Surya Kant said that the brief chart is already there and requested Director AIIMS Patna to read it and clarify why the two were eligible and the three were not eligible. As the chart has already been given as Annexure.

Director, AIIMS Patna readout the remark/recommendation as recorded by the Committee in case of Dr. Meenakshi Tiwari and Dr. K. K. Sharma.

Shri Nilambuj Sharan, Secretary PMSSY, said that power to relax minimum qualifications lies with the Selection Committee. And if this power was to be exercised, it should have been exercised and recorded by the Selection Committee. It was for the Selection Committee to do so, how can it be done now post-facto.

Dr. Rajesh Upadhyay said that the decision of the Selection Committee must be honoured and if they have in knowledge of the fact that the candidate is more than 50 years and yet they have not only accepted but selected the candidate, it means that they have given him that relaxation which is within the regulation.

Shri Sanjay Jaiswal opinion that all the GB members who are present here and if all are accepting it then it is time to accept this. Having a doctor with so much qualification is in the interest of the Institute.

All the members accepted and the Chairman Dr. N. K. Arora said that the appointment of two people were correct and we should terminate other three people.

Shri P. K. Singh, Director, AIIMS Patna sought view of the Governing Body to know whether he should opt for the direct termination or follow the whole procedure, since, there is a defined way of terminating someone.

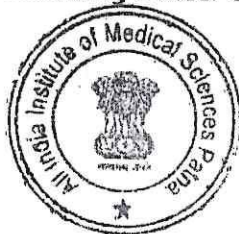
The chairman of the Governing Body asked Shri Nilambuj Sharan to enlighten the Governing Body on it.

Shri Nilambuj Sharan said that we should go by all the process and procedure which should include the departmental proceedings and all other things otherwise it will become a sub-judice matter. So the process has to be followed.

Shri N. K. Arora, Chairman of the Governing Body thereafter asked the Director, AIIMS Patna to go ahead with the due process.

Director, AIIMS, Patna further requested the GB Members to authorise the President for all approvals that are needed from the Governing Body like issue of Charge sheet, appointing Enquiry Officer and Presenting Officer etc.
