The 8th Meeting of the Standing Finance Committee (SFC) of AIIMS Patna was held on 13th September 2024 at 11:00 PM, in Room No. – 155, A Wing, 1st Floor, Nirman Bhawan, New Delhi under the Chairmanship of Shri Apurva Chandra, I.A.S., Secretary, Ministry of Health & Family Welfare, Government of India.

Shri Amrit Lal Meena, Chief Secretary to Government of Bihar Prof. (Dr.) Atul Goel, Director General of Health Sciences, Dr. Rajesh Upadhyay and Dr. Viswambhar Singh could not attend the meeting and leave of absence was granted to them by the Chairman.

The Chairperson called the meeting to order and requested Member Secretary to introduce the Agenda and initiate discussions on the Agenda items.

The deliberations on the Agenda items are as follows:

Agenda Item no. - SFC 08/01

Welcome address by Chairman, SFC (Secretary MoHFW).

Dr. Gopal Krushna Pal, Member Secretary of SFC, presented an updated status of the work and activities of AIIMS Patna. It was informed that AIIMS Patna was Ranked 26th in Medical Category in National Institute Ranking Framework (NIRF) Ranking. The Microbiology Department at AIIMS Patna has received the accreditation certificate from the National Accreditation Board for Testing and Calibration Laboratories (NABL). AIIMS Patna has received the approval for starting kidney transplant on 09.07.2024 by the State Organ and Tissue Transplant Organization (SOTTO). It was informed that the Burns Centre under CSR is nearing completion and the work of the Critical Care Block under PM ABHIM is going on in full swing. An eye bank is also being established in collaboration with LV Prasad Eye Institute, Hyderabad.

Agenda Item no. - SFC 08/02

Confirmation of the Minutes of the 7th Meeting of Standing Finance Committee of AIIMS Patna held on 1st February 2024.

Member-Secretary informed that Minutes of the 7th Meeting of Standing Finance Committee was circulated to all Members and no comments were received. Accordingly, Standing Finance Committee confirmed the Minutes of the 7th Meeting of SFC of AIIMS, Patna.

Agenda Item no. - SFC 08/03

Action Taken Report on Minutes of the 7th Meeting of Standing Finance

Committee of AIIMS Patna

SFC noted the Action Taken Report presented by the Member-Secretary on the decisions of the 7th Standing Finance Committee meeting. It was decided to carry forward the following Agenda items where the action was not complete.

Agenda Item No. SFC/07/03: To consider and approve construction of Administrative Building at AIIMS Patna through GIA – Capital

Agenda Item No. SFC/07/04: To consider and approve construction of Second Guest House through GIA – Capital

It was noted that revised proposal for construction of Administrative Building and Second Guest House incorporating the observations of the previous SFC are awaited from the Institute .

Agenda Item No. SFC/07/06: To consider procurement of (i) Core Switch (Network) – Rs. 13 Cr. (ii) Next Generation Sequencer (NGS) – 16 Cr. and (iii) 256 Slice CT Scan – 15 Crores

The ED informed that the procurement of Core Switches is being undertaken by HITES . He also informed that the specifications of Next Generation Sequencer (NGS)NGS and 256 Slice CT Scan was in the process of vetting by External Experts. As regards procurement of 256 slice CT , SFC advised ED to await the specifications to be issued by the committee set up by the Ministry .

Agenda Item no. - SFC 08/04

To consider and approve construction of Comprehensive Cancer Care Centre at AIIMS Patna through GIA – Capital at a cost of Rs. 384.38 Cr

The ED, AIIMS Patna made a presentation about the number of cancer patients, the faculty strength in various departments taking care of cancer patients and the current cancer care facilities available at AIIMS Patna.

After detailed deliberation, the SFC agreed in principle to the need for setting up of Comprehensive Cancer Care Centre at AIIMS Patna. However, SFC noted that

proposed cost of Rs. 384.38 cr. is abnormally high .

Accordingly, the Institute was advised to revise and rationalize the cost of civil construction, equipment, furniture, manpower etc and submit the proposal complete in all respect before the next SFC for consideration .

Agenda Item no. - SFC 08/05

To consider and approve establishment of Simulation Lab at AIIMS Patna through GIA – Capital at a cost of Rs. 48 Crores

While agreeing to the need of setting up of a Simulation lab for teaching and learning , SFC noted that the costing of the proposed Simulation Lab was significantly on the higher side .After detailed deliberation SFC advised that the guidelines prepared by DGHS for setting up of skill labs in Institutes may be referred to by the Institute and the proposal may be reworked and re submitted .

Agenda Item no. - SFC 08/06

To take a note of Details of BE, RE and Grant-In-Aid Received, Expenditure incurred and closing Balance for the Financial Year 2023-2024 and to consider and approve the Expenditure for the financial year 2024-25 of AIIMS PATNA

The SFC noted and approved the following budget estimates for the FY 2024-25

To consider and approve procurement of Intraoperative Radiotherapy (IORT) – ₹ 16.6 Crores

SFC considered and approved the proposal of the institute to procure Intraoperative Radiotherapy (IORT) Machine (for treatment of cancer through radiation)through competitive bidding in accordance with GFR / procurement manual and other guidelines issued by the GoI on the subject .The duration of warranty and CMC to be fixed as per the guidelines issued by the Ministry.

Agenda Item no. - SFC 08/08

To consider and approve procurement of O arm with Navigation and Compatible Instruments – ₹ 10,19,00,000/-

SFC approved the proposal for procurement of O arm with Navigation and Compatible Instruments as per the specification approved by the committee set up by MoHFW through competitive bidding in accordance with GFR /procurement manual and other guidelines issued by the GoI on the subject .The duration of warranty and CMC to be fixed as per the guidelines issued by the Ministry.

Agenda Item no. - SFC 08/09

To consider and approve procurement of 3 Operating Microscope - ₹ 16 Crores

SFC considered the proposal of the Institute and noted that the Institute already has 3 Operating Microscopes(2 in Ophthalmology and 1 in Burns and Plastic surgery) and in order to ensure optimal utilization of the available equipment's, SFC approved purchase of two Operating /Surgical Microscope (One each for Department of Ophthalmology and Orthopaedics) through competitive bidding in accordance with GFR and other guidelines issued by the GoI on the subject .The duration of Warranty and CMC to be fixed as per the guidelines issued by the Ministry.

Agenda Item no. - SFC 08/10

To consider and approve procurement of Prosthetic and Orthotic Workshop -

₹ 11,50,49,200/-

The SFC considered and approved the setting up of Prosthetic and Orthotic Workshop at AIIMS Patna at an estimated cost of ₹ 11,50,49,200/- including civil works and procurement of machineries and equipment .SFC advised the institute to undertake procurement through competitive bidding in accordance with GFR and other guidelines issued by the GoI on the subject .

Institute was also advised to collaborate with the Ministry of Social Justice and Empowerment in this regard for identification of patients and delivery of treatment

Agenda Item no. - SFC 08/11

To consider and approve procurement of Bi-Plane Cardiac Catheterization Laboratory (Cath Lab) machine - ₹ 13,50,00,000/-

SFC approved the establishment of Bi-Plane Cardiac Catheterization Laboratory (Cath Lab) at AIIMS Patna as per the specification approved by the committee set up by MoHFW through competitive bidding in accordance with GFR /procurement manual and other guidelines issued by the GoI on the subject .The duration of warranty and CMC to be fixed as per the guidelines issued by the Ministry.

SFC further advised that while undertaking procurement of medical equipment reference may be drawn to the last purchase price of the equipment to ascertain rate reasonableness .

Agenda Item no. - SFC 08/12

To consider and adopt Audited Annual Accounts and separate Audit Report for the Financial Year 2022-2023 of AIIMS Patna

The SFC took note of the Separate Audit Report of AIIMS Patna for the Financial Year 2022-23.

Agenda Item no. - SFC 08/13

To ratify the approval of the list of the Tenders issued and accepted by AIIMS Patna through GeM Portal, CPP Portal and list of the Single Tender/ Proprietary Nature Procurements by AIIMS Patna during F.Y.-2023-2024

It was clarified that ratification of apx 500 tenders by the SFC in the meeting was not possible . The SFC advised the Institute to strictly adhere to the GFRs /Procurement Manual and other Guidelines of the of the GoI as issued from time to time .

SFC took note of the nomination of Sh Arun Chandra Verma IPS (Rtd) as Independent External Monitor at AIIMS Patna by the Central Vigilance Commission .

Agenda Item no. - SFC 08/14

To consider and approve the implementation of revised DA rates for journey on duty in various countries.

The SFC considered and approved the adoption of DA rates for journey on duty to various countries as per OM No.- Q/FD/695/03/2000 dated 25th September 2023 issued by MEA as amended from time to time .

Agenda Item no. - SFC 08/15

To consider and approve Higher Degree Allowance (Qualification Pay) to Nursing Staff at AIIMS Patna

The SFC noted that the proposal has a common implication for all AIIMS and therefore deferred the proposal and advised the Institute to await the instructions of MoHFW on the matter.

Agenda Item no. - SFC 08/16

Consideration for Hospital Patient Care Allowance (HPCA) for non-faculty (Non-ministerial) staff of the institute.

The SFC advised the Institute to grant payment of HPCA to the eligible Non-ministerial) staff of the institute ONLY as per the provisions of the Ministry's O.M.

21.04.2023. With regard to the eligibility criteria, it was emphasized that the employees whose regular duties involve continuous and routine contact with patients infected with communicable diseases or those who have to routinely handle, as their primary duty, infected materials, instruments and equipment's which can spread infection as their primary duty may be considered for grant of HPCA.

Agenda Item no. - SFC 08/17

For kind notice of SFC about engagement of 6 posts of Consultants through Contractual Appointment

The SFC noted that these post are not included in Standard Staffing Pattern approved for all New AIIMS set up under PMSSY. Also clarity was not provided in the agenda as to how the proposed salary of the consultants has been arrived at. It was noted that IT positions have already been approved for the Institute . It was not clear whether these have been filled up . The need of Consultant projects /network Administrator could not be justified .It was not clear whether the proposal was in accordance with the Guidelines for engagement of Consultants issued by the Ministry.

Accordingly, the Institute was advised to revisit the proposal including justification and financial implication .

Agenda Item no. - SFC 08/18

To consider and approve the grant of Non-Practice Allowance (NPA) to Senior Medical Officer and Medical Officer of AYUSH Department at AIIMS Patna

SFC considered the proposal of the Institute for grant of Non-Practice Allowance (NPA) to Senior Medical Officer and Medical Officer AYUSH Department. PMSSY Division was advised to examine the issue in light of the Recruitment Rules and the practice followed in other Institutes . As required the Ministry of AYUSH may be consulted .

Balasubramanian, US MoHFW and Shri. Nilotpal Bal, DDA, AIIMS, Patna attended the meeting as special invitee.

The Chairperson called the meeting to order and requested Member Secretary to introduce the Agenda and initiate discussions on the Agenda items.

Dr. Gopal Krushna Pal, Member Secretary of SFC, made a brief presentation before the committee regarding some of the major works done and major achievements at AIIMS Patna.

The deliberations on the Agenda items were as follows:

Agenda Item no. - SFC 07/01

Confirmation of the Minutes of the 6th Meeting of Standing Finance Committee of AIIMS Patna Held on 07th JULY, 2023.

Since there were no observations/ comments from the members of the committee, the minutes of the 6th meeting of the Standing Finance Committee meeting held on 07th July 2023 were confirmed.

Agenda Item no. - SFC 07/02

Action Taken Report (ATR) on Minutes of the 6th Meeting of Standing Finance Committee of AIIMS Patna

The Action Taken Report (ATR) on the minutes of the 6th Standing Finance Committee meeting was presented before the Standing Finance Committee by the Member Secretary.

The ATR on the minutes of the 6th SFC was taken note of and was deliberated upon by the committee

Secretary HFW emphasised that the agendas where action has not been completed should be carried forward to the next SFC meeting. This was essential to ensure that the decisions of the SFC are complied with in a time bound manner.

After consideration of the Action taken Report SFC directed the following Agenda Items where action is yet not complete to be carried forward for review to the next SFC

- i. **Agenda Item No. SFC/06/03:** To note and approve the Drone Project at AIIMS Patna through GiA Capital. AIIMS Patna informed that demonstration of all qualified vendors was underway, once the same is completed the the price bid will opened to finalize the vendor at the earliest.
- ii. **Agenda Item No. SFC/06/04, SFC/06/05 and SFC/06/06:** SFC was informed that the proposal for construction of Emergency Medicine Hospital, Girls' Hostel and Boys' Hostel and Type 2, 3 and 4 Quarters at AIIMS Patna has been clubbed together .The DIB meeting of the project is scheduled to be held .
- iii. **Agenda Item No. SFC/06/08:** As regards provision of stipend to Ph.D. students, it was informed that the matter is under consideration in the Ministry in consultation with Department of Health Research . The Institute was advised to await further instructions from the Ministry in the matter.
- iv. **Agenda Item No. SFC/06/09:** Proposal for post creation for the Department of Burns , Department of Clinical and Intervention Physiology to be submitted by the Institute to the Ministry

Agenda Item no. - SFC 07/03

To consider and approve construction of Administrative Building at AIIMS Patna through GiA – Capital at an estimated cost of Rs 49.18 Cr

The SFC considered the proposal in detail and advised the Institute to revisit the proposal and submit the same with floor wise details of the total area to be built , number of officials and staff to be accommodated as per norms in place including the proposed plan for utilization of the space to be vacated in the current Medical College building used for Administrative Wing .The Institute was advised to ensure economic and effective utilisation of space while finalising the proposal .It was also advised that for multiple positions held by a faculty separate rooms need not be provided .

Accordingly, the Institute was advised to send a detailed proposal along with

financial implication and justification to the Ministry for consideration of the Competent Authority.

Agenda Item no. - SFC 07/04

To consider and approve expansion of Guest House through GIA – Capital

The Member Secretary informed the committee that the available Guest House at AIIMS Patna is small and does not have sufficient rooms to accommodate guests and experts during conduct of examinations and interviews by Standing Selection Committee. It was informed that the current guest house cannot be expanded vertically and therefore a separate block will be constructed for which land is available in the vicinity.

Considering the existing capacity of Guest House at AIIMS Patna and the current and future requirements of accommodation for guests, SFC approved in-principle the proposal for expansion of the Guest House at an estimated total cost of Rs 16.47 Cr.

Accordingly, the Institute was advised to send a detailed proposal along with financial implication and justification to the Ministry for consideration of the Competent Authority.

SFC further advised that the quality of service of the guest house should be improved by outsourcing the same to Hospitality Management Agencies on the pattern adopted by IIMs and IITs.

Agenda Item no. - SFC 07/05

To consider and approve the RE for the financial year 2023-24 of AIIMS Patna

The Member Secretary presented the revised budget estimates for the financial year 2023-24. In light of the funds available the following RE 2023-24 was approved by the SFC. It was clarified that in case of savings in the capital head further funds as per the requirement projected by the Institute will be released.

Agenda Item no. - SFC 07/06

To consider and approve procurement of items above 5 Crores –

- i. Core Switch (Network) – Rs. 13 Crores
- ii. Next Generation Sequencer (NGS) – 16 Crores
- iii. 256 Slice CT Scan – 15 Crores

SFC approved the proposal for procurement of Core Switch (Network), Next Generation Sequencer and 256 Slice CT Scan. DGHS apprised the SFC that centralised specification are being made by DGHS for procurement of high end and commonly used equipments which will be a useful guidance document for the various AIIMS .

Agenda Item no. - SFC 07/07

To note and approve the construction of Boundary Wall around Hostel Complex at AIIMS Patna

The SFC took note of the proposal for construction of Boundary Wall around Hostel at AIIMS Patna at a cost of Rs. 4,10,36,476/-, which is within the delegated financial powers of ED, through funding by GIA Capital from Ministry of Health & Family Welfare. It was advised to follow scrupulously the GFR and extant instructions of the Government in the matter.

Agenda Item no. - SFC 07/08

Any other issue with the approval of Chairman

- (i) For kind information of SFC regarding Hike in stipend of interns at AIIMS Patna as done at AIIMS Delhi and AIIMS Bhopal.

The SFC clarified that the proposal for payment of Rs.30,070/- per month to MBBS students during their internship has been referred by the Medical Education Division of the Ministry to Department of Expenditure for consideration and

approval. The proposed enhanced rates of monthly stipend cannot be implemented without the approval of the Department of Expenditure. The Institute was therefore advised to await further instructions from the Ministry in the matter.

(ii) Newspaper Allowance for Nursing Staff at AIIMS Patna.

The SFC approved the proposal to grant Newspaper Allowance for eligible Nursing Staff at AIIMS Patna in pay level 8 and above as per Department of Expenditure OM dated 03.04.2018

(iii) Proposal to grant Higher Administrative Grade (HAG) scale to upto 40% of Professors at the institute.

The SFC noted that the proposal has implication for all the new AIIMS. The policy decision is be taken for all new AIIMS after examination/deliberation and with the approval of Competent Authority/DoE. The proposal was accordingly deferred.

(iv) Information regarding projects under CSR at AIIMS Patna.

The ED informed the SFC that a Burn Hospital is under construction at AIIMS Patna under CSR funding from NTPC. The Executing agency for the construction was CPWD. 90% of the construction is complete and the fund under civil works had been utilized.

The ED also informed that there was increase in the project cost by Rs 4.87 crores as informed by CPWD and the same may be approved for utilisation from the Capital Grant in aid released to the Institute as no additional funds were forthcoming from NTPC.

SFC approved the proposal and advised the ED to adhere to the the GFR and extant instructions of the Government in the matter.

The meeting concluded with a vote of thanks proposed by Executive Director to the Chair, all members and special invitees.

Senior Director and Head, Gastroenterology and Hepatology, Max Super Specialty Hospital, New Delhi, who attended the meeting through virtual mode.

Prof. (Dr.) Atul Goel, Director General of Health Services, MoH&FW and Shri Amir Subhani, Chief Secretary to Government of Bihar could not attend the meeting and leave of absence was granted to them by the Chairman.

The Chairperson called the meeting to order and requested Member Secretary to introduce the Agenda and initiate discussions on the Agenda items.

Dr. Gopal Krishna Pal, Member Secretary of SFC, made a brief presentation of the major works done and major achievements at AIIMS Patna during last one year, as he completed the first year at AIIMS Patna on 3rd July, 2023 as follows

- (i) The first Rolling Advertisement model for Faculty Recruitment was done at AIIMS Patna, and Faculty Recruitments have been conducted in two phases; one in November 2022 and next in February 2023, due to which the number of faculty strength at AIIMS Patna has increased from 113 before he joined the institute to 219 after the two recent recruitments.
- (ii) Due to increased Faculty and resident doctors' strength the quality of hospital services at AIIMS Patna has improved significantly, currently the footfall of OPD patients is about 5000 per day.
- (iii) New academic departments of Nephrology, Neurology, Neonatology and Cardiology have started functioning at AIIMS Patna with initiation of new DM courses in these departments.
- (iv) At AIIMS Patna six years integrated MCh courses in CTVS, Trauma Surgery and Gastro surgery & DM in Clinical-Interventional Physiology has been initiated from this academic year.
- (v) The construction of Burn Hospital will be completed by August end by CPWD, the executive agency.

The work done by Dr. G. K. Pal as Executive Director of AIIMS Patna in his first year was highly appreciated by all the members.

The Chairman pointed out that still there are 86 vacancies of the faculty posts and about 1500 non-faculty posts at AIIMS Patna. He advised the ED to take all necessary steps to fill-up all these posts in a time bound manner as part of the Mission Recruitment. Dr. Pal informed that difficulties were being faced due to non-availability of faculty for the posts of Professor and for some of the posts in reserved categories. The Chairman advised the ED to explore the possibility of

recruitment of senior faculties through e-Sresta (Scheme to deploy Superannuated Medical Teachers from Armed Forces in Medical Colleges). Chairman also suggested that for conducting recruitment of non-faculty the option of engaging government agencies such as EDCIL, BECIL, NILED, and NTA should be explored. The ED AIIMS Patna assured the committee that all the suggestions of the Hon'ble Chairman will be implemented.

CONFIRMATION OF THE MINUTES OF THE 5TH MEETING OF STANDING FINANCE COMMITTEE OF AIIMS PATNA HELD ON 23RD DECEMBER, 2022.

Decision taken: Minutes of the 5th Meeting of Standing Finance Committee of AIIMS Patna held on 23rd December 2022 were confirmed.

Agenda Item no. - SFC 06/02

Action Taken Report on Minutes of the 5th Meeting of Standing Finance Committee of AIIMS Patna

Decision taken: Action Taken Report of the 5th Meeting of Standing Finance Committee of AIIMS Patna held on 23rd December 2022 was noted by the Committee.

Agenda Item No. SFC/05/02: ED AIIMS Patna informed the Committee that Hon'ble M.P. Shri Sushil Kumar Modi Ji has granted Rs. 3 crore from his MP LAD Fund to AIIMS Patna for construction of Dharamshala at AIIMS Patna. The construction plan for Dharamshala has already been prepared by the Engineering Division of AIIMS Patna. However, this will only be a sitting kind of Dharamshala for about 1500 people, with facilities for washrooms in a single storied structure. Overnight sleeping facilities with provision of couches cannot be done as Rupees 3 crores would not be sufficient for the construction of a full-fledged two storied Dharamshala at AIIMS Patna.

SFC advised the ED to seek additional funds from other Hon'ble MPs of Bihar from their respective MP LAD Fund for construction of a full-fledged Dharamshala

at AIIMS Patna or funds could also be sourced from govt PSUs as part of CSR initiative . AS&FA suggested that a State Government managed indigenous food court for the public in the Dharamshala at a lower cost can be provided, as it is functioning at AIIMS Bhubaneswar. He requested ED AIIMS Patna to approach the Government of Bihar to setup such a food court at subsidized rate at the Dharamshala of AIIMS Patna.

Agenda Item No. SFC/05/03 & 04: Ed AIIMS Patna informed that as per the recommendations of last SFC, the revised proposal clubbing Screening OPD and the Super Specialty Hospital has been submitted to the Ministry for in-principle approval of the Department of Expenditure .The cost of construction has been optimized from Rs. 268 Crores to Rs. 199.68 Crores in the revised proposal.

Agenda Item No. SFC/05/06: The ED informed that work of the construction of two Lecture Theatres at AIIMS Patna has been entrusted to CPWD as the Executive Agency, and advance amount of Rs. 9.99 Crores (of the total cost of 15 Crores) has been paid to CPWD. The construction of Lecture Theatres by the contractor has started.

Agenda Item No. SFC/05/07: The ED informed that the work of the construction of Outdoor Sports Complex at AIIMS Patna has been entrusted to CPWD as the Executing Agency. Advance amount of Rs. 16.79 Crores (of the total cost of 20.28 Crores) has been paid to CPWD, and the construction work of Outdoor Sports Complex has started.

Agenda Item No. SFC/05/08 & 09: In the last SFC, AIIMS Patna was advised to resubmit the proposal of construction of Girls' and Boys' Hostel in accordance with the a Gap analysis. The ED informed that as per the instructions, the details of construction of Girls' and Boys' Hostel has been presented as Agenda Item No. SFC 06/05.

Agenda Item No. SFC/05/16: In the last SFC, Institute was advised to make a presentation on the proposal for intramural research grants for UG and PG students with complete details of such grants available in other institutes, the quantum of grants to be given at AIIMS Patna and how many students in each category will avail the grant and how the approval will be given and monitoring of such grants will be ensured in the institute.

After detailed deliberation SFC approved the provisioning of a composite fund

of Rs.5 lakhs per annum for research/ innovation related activities, paper presentation, report preparation ,participation in conference etc for MBBS and BSc Nursing students .

On similar lines SFC also approved provisioning of Rs.10 lakhs per annum for similar activities for Post Graduate Academic Residents (MD/MS/MDS/DM/MCh)

A student to be provided support from the fund only once in an academic year. The expenditure for the above funds to be met form internal revenue of the Institute.

The Action Taken Report (ATR) of Minutes of 5th Meeting of SFC, AIIMS Patna was taken note by SFC.

Agenda Item no. - SFC 06/03

To note and approve the Drone Project at AIIMS Patna, through GIA- Capital

Decision Taken: The SFC noted that the proposal submitted by the Institute was under consideration in NHSRC. The SFC approved the proposal of the Institute to implement the Drone Project in-principle and advised the Executive Director, AIIMS Patna to consult NHSRC (National Health Systems Resource Centre) for technical assistance and follow the guidelines issued by NHSRC for use of drones. 


